

IMPORTANT:

- If you are intending to keep this vessel on a mooring or if the vessel has been previously registered contact the NSW Maritime Infoline on **13 12 56** – within NSW (**8.30am to 4.30pm**) – **7 days a week**. For all other areas call (02) 9563 8557.
- Applications must be accompanied by Proof of Identity (POI) and prescribed fee. For a full list of acceptable POI requirements, current fees and further information contact NSW Maritime on the appropriate number listed above.
- Vessel registration can only be applied for in an individual's name except for marine dealers, motor vehicle dealers and finance/insurance companies for the purposes of resale and other approved organisations.
- Certain volunteer organisations and educational institutions may be eligible for gratis registration in the organisation's name. Conditions apply. For more details call the appropriate number listed above.
- Applicants must have attained the age of 16 years to register a vessel in their name.

To obtain vessel registration the applicant must:

- Provide, if the vessel is not to be registered in owner's name, signed written advice from the owner stating that the vessel is to be registered in applicant's name rather than the name shown on the receipt or Bill of Sale.

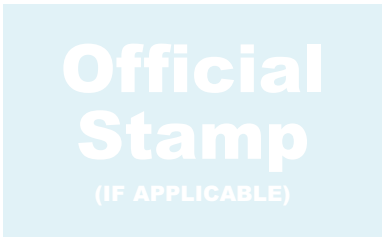
